Investment objective

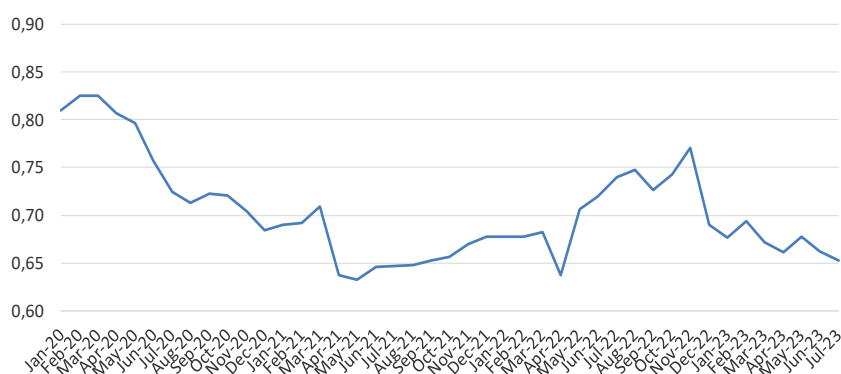
